Due to far-reaching measures for implementation currently we cannot represent and document the China -RoHS. However, they are currently being processed.

The RoHS-Regulation 2011/65/EU also named RoHS-II and their requirements are compiled by us (see separate declaration).

ESKA Erich Schweizer GmbH complies nationally and internationally in principle with laws, applicable directives, standards and regulations and in parallel continuously monitors all changes that affect, for example, the scope, the CE marking or expiry dates of exemptions.

We take our obligations very seriously in our own interest and under the aspect of the greatest possible product and delivery safety. The following procedure supports compliance with applicable regulations and legal requirements:

Our suppliers undertake to comply with substance bans and declaration obligations in accordance with RoHS. Newly developed ESKA products that fall under the scope of the RoHS Directive are basically RoHS compliant.
